GENERAL INFORMATION

CUSTOMER CHARGE:

This monthly charge covers some of the fixed costs of being connected to the electric, water and wastewater systems.

ENERGY CHARGE:

The total cumulative quantity of electric energy delivered during the billing period measured in kilowatt hours (kWh).

DEMAND CHARGE:

The peak single moment of electric energy consumption during the current billing period on-peak hours, measured in kilowatts (kW).

DISTRIBUTION DEMAND CHARGE:

The peak single moment of electric energy consumption during the current month or preceding 11-month period regardless of time of day, measured in kilowatts (kW).

POWER COST ADJUSTMENT CLAUSE:

This adjustment reflects the difference between the actual cost of power each month and the base cost of power already included in rates.

WISCONSIN SALES TAX:

All sales of electrical energy are subject to the 5% Wisconsin Sales Tax and 0.5% Fond du Lac and Dodge County Tax. In February 1979 a law (S77.54(30)) was enacted providing a Sales and Use Tax Exemption for electricity sold for residential or farm use during the months of November through April.

COMMITMENT TO COMMUNITY

State required funding of low income assistance and energy efficiency programs. The charge shall not exceed the greater of the monthly amount shown or 3.0% of the electric bill.

DEMAND/ENERGY LIMITER

Small Power Time-of-Day Service Customers with lower load factors shall be billed the lesser of the demand charge plus the energy charge or \$.1296 per kWh each month.

COMMERCIAL DISCOUNTS

Available to Cp-1, Cp-2, Cp-3 & Cp-4 customers

- **Primary Metering:** 2.0% discount on the monthly energy charge, distribution demand charge, and demand charge for customers metered on the primary side of the transformer.
- **Transformer Ownership:** \$.25 per kW of Distribution Demand credit given to customers who own and maintain their own transformers or substations.
